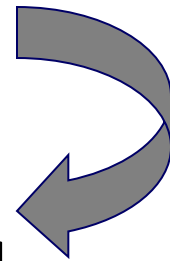

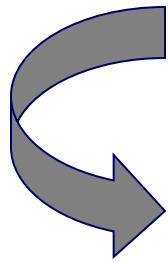

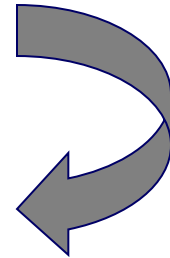

“FONDIMPRESA”

Each company can be financed under two different schemes:

- **“Conto Formazione”**
(individual account, financed by 70% of “0,30% contribution”)
- **“Conto di Sistema”**
(collective account, financed by 26% of “0,30% contribution”)

Main training programmes on:

- health and safety at work
- informatics and computing
- languages
- production
- administration

73.000 companies
3.400.000 workers

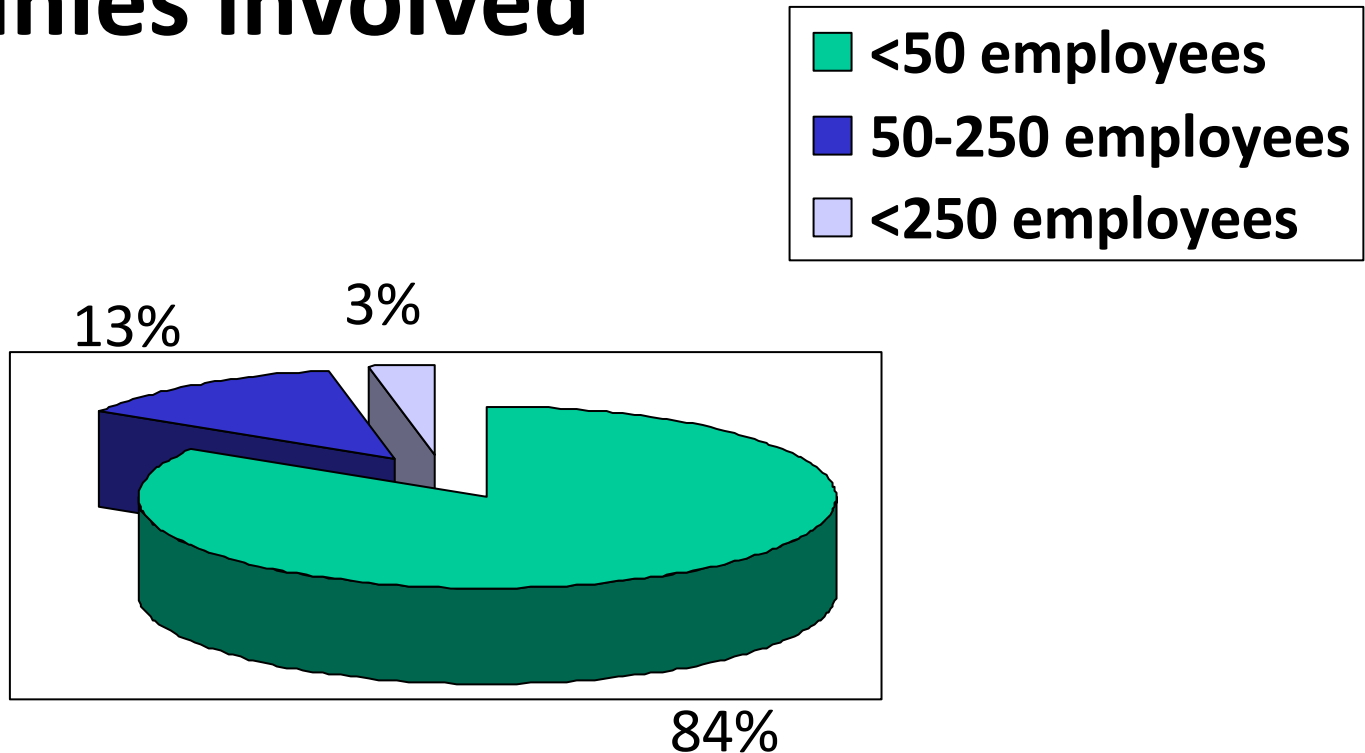

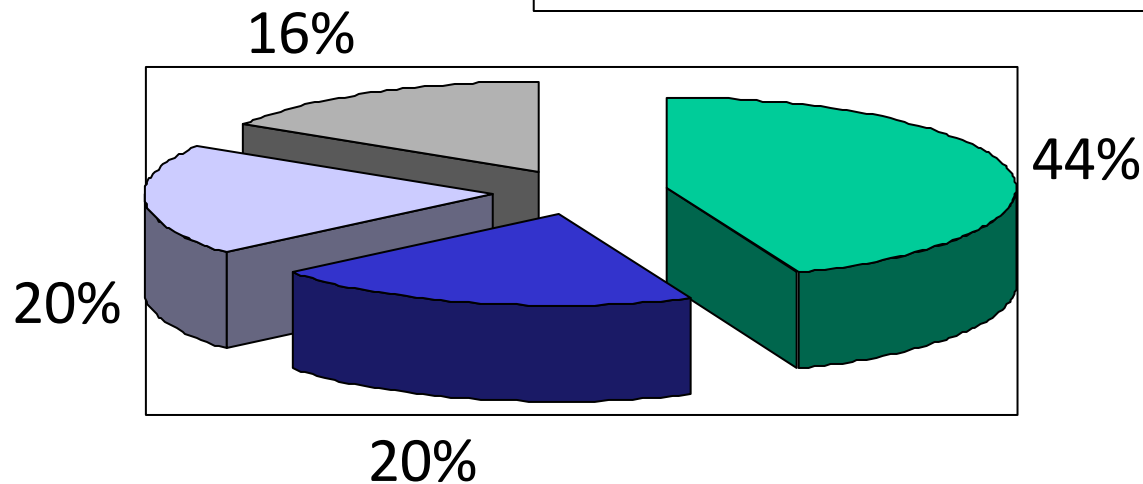

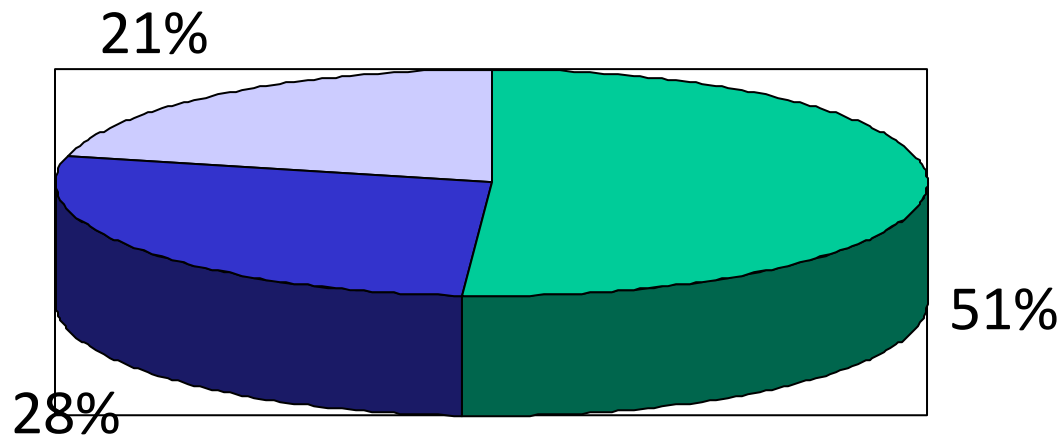

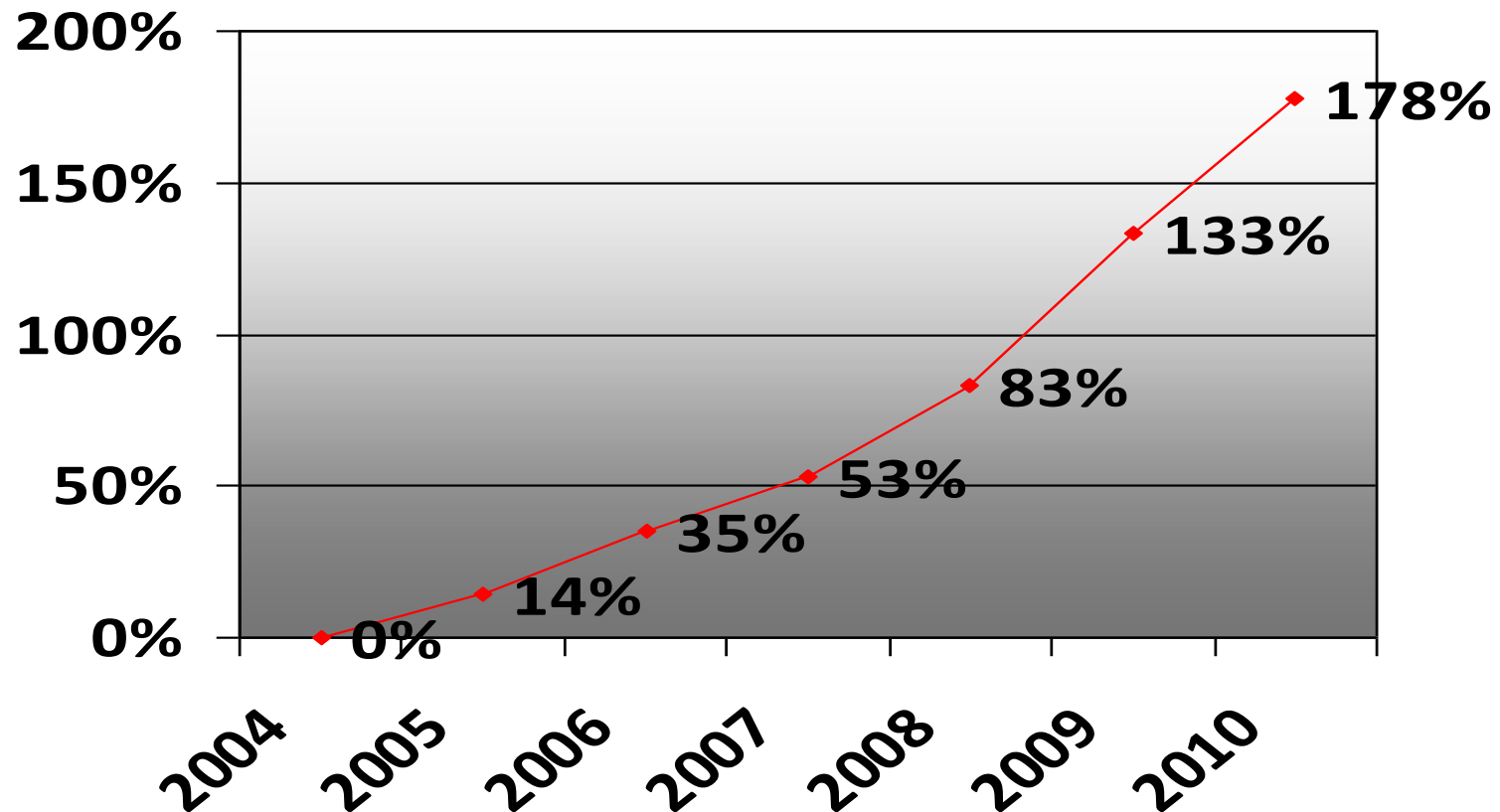


More than 30% of the workers involved in training are over 45

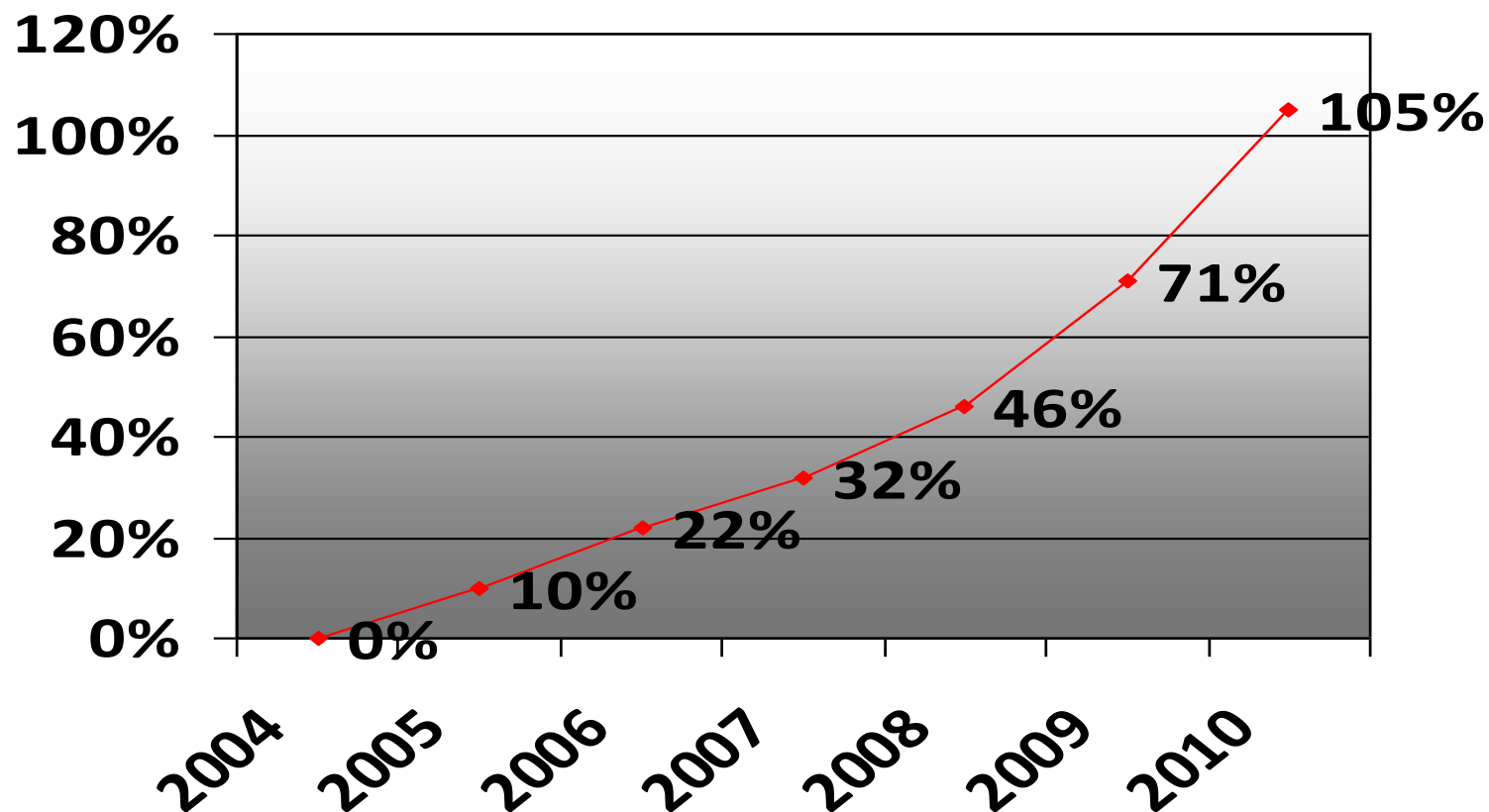


About 23% of the workers involved in training are over 34
