I. Autonomous work programme

Working period: 2015-2017

“Partnership for inclusive growth and employment”

- **Contribute autonomously to policies** affecting directly or indirectly employment and labour markets
- **Foster and strengthen the development of autonomous social dialogue** across European countries
- **Act at bipartite and tripartite levels**, taking possible European Commission upcoming proposals and initiatives as basis
- **Develop social partners’ role** in the process of the European Semester



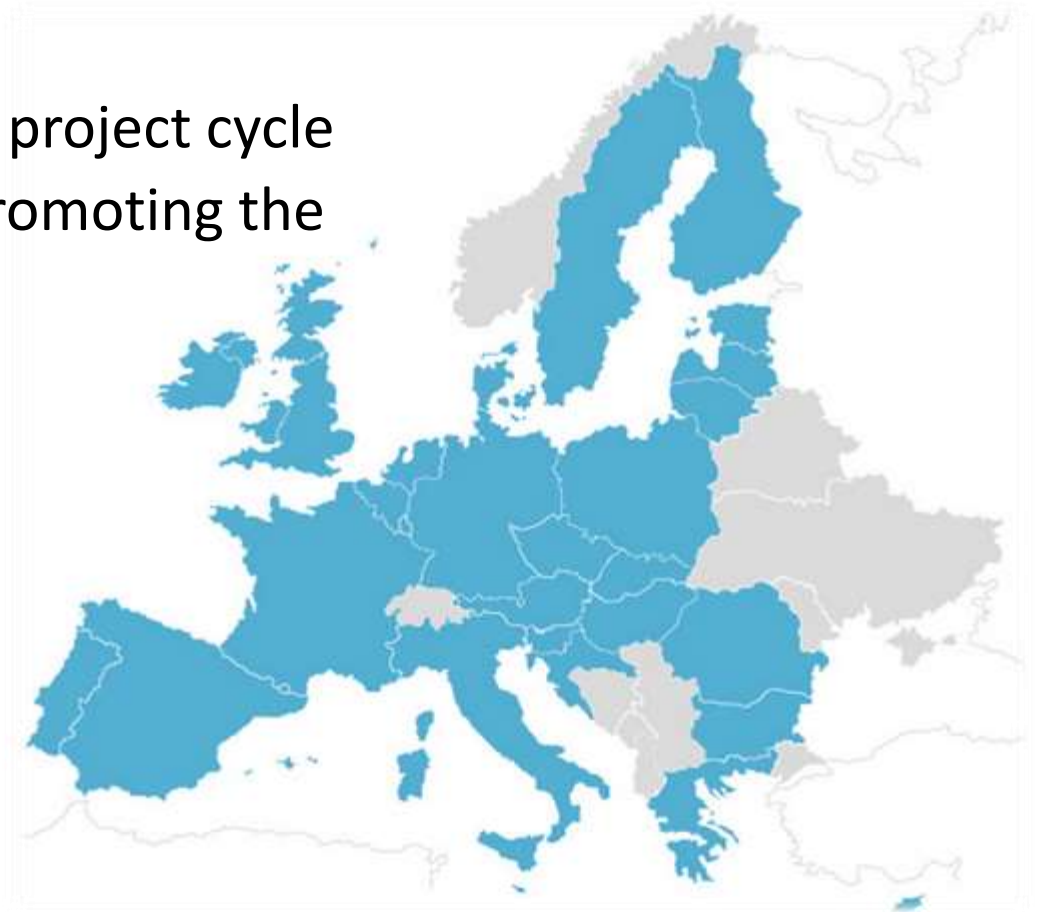
I. Autonomous work programme

- Ongoing activities:
 - Fostering active ageing in an inter-generational approach
 - Mobility and migration
 - Investment package and strengthening the industrial base in Europe
 - Skills needs in digital economies
 - Committing to promote capacity building and better implementation outcomes
- Foreseen:
 - Promoting better reconciliation and gender equality to reduce the gender pay gap
 - Active labour market policies



II. Integrated projects

- Ongoing: 2014-2016
 - Today's conference marks the end of this project cycle
 - Four decentralised cluster seminars on promoting the European social dialogue organised

 - One seminar for candidate countries
Serbia
 - One seminar on ESF for capacity building
Latvia



II. Integrated projects

- Ongoing: 2014-2016
 - Separate trade unions and employers research projects on apprenticeship, including separate cluster seminars and conferences, final joint conference, and experts reports
 - “A European Quality Framework for Apprenticeships” (ETUC)*
 - “The Cost Effectiveness of Apprenticeship Schemes” (BUSINESSEUROPE, CEEP, UEAPME and other partners)*



II. Integrated projects

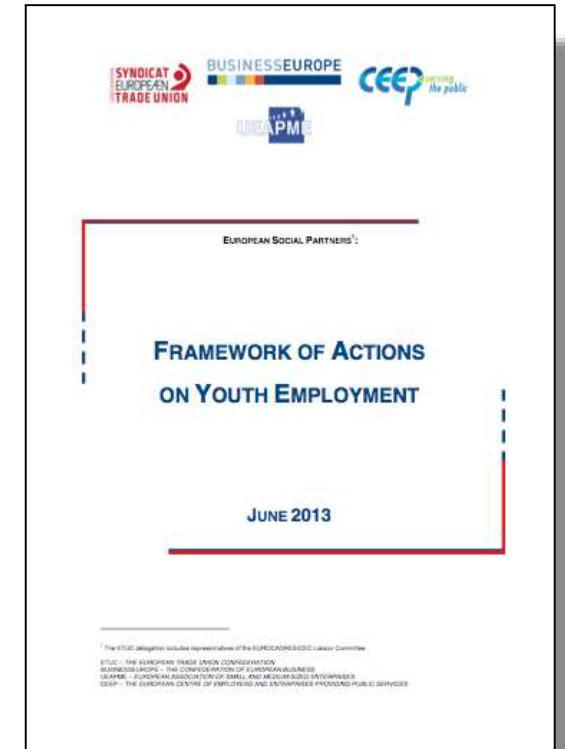
- Foreseen: 2016-2018
 - Application sent to the European Commission
 - Three **cluster seminars on reinforcing European social dialogue and industrial relations**
 - One **seminar for candidate countries** on training / mentoring / capacity building
 - Two **cluster seminars on social partners' involvement in economic governance**
 - One **conference on promoting and reinforcing EU social dialogue**

II. Integrated projects

- Foreseen: 2016-2018
 - One **conference on youth employment Framework of Actions**
 - One **fact-finding seminar on digitalisation**
 - Thematic research on **employee training** and fostering the social partnership approach for skills development at all levels
 - Expertise work, cluster seminars, final conference, report*
 - Thematic research on the **use of the ESF for supporting social dialogue** at national, regional and local levels
 - Expertise work, cluster seminars, final conference, report*

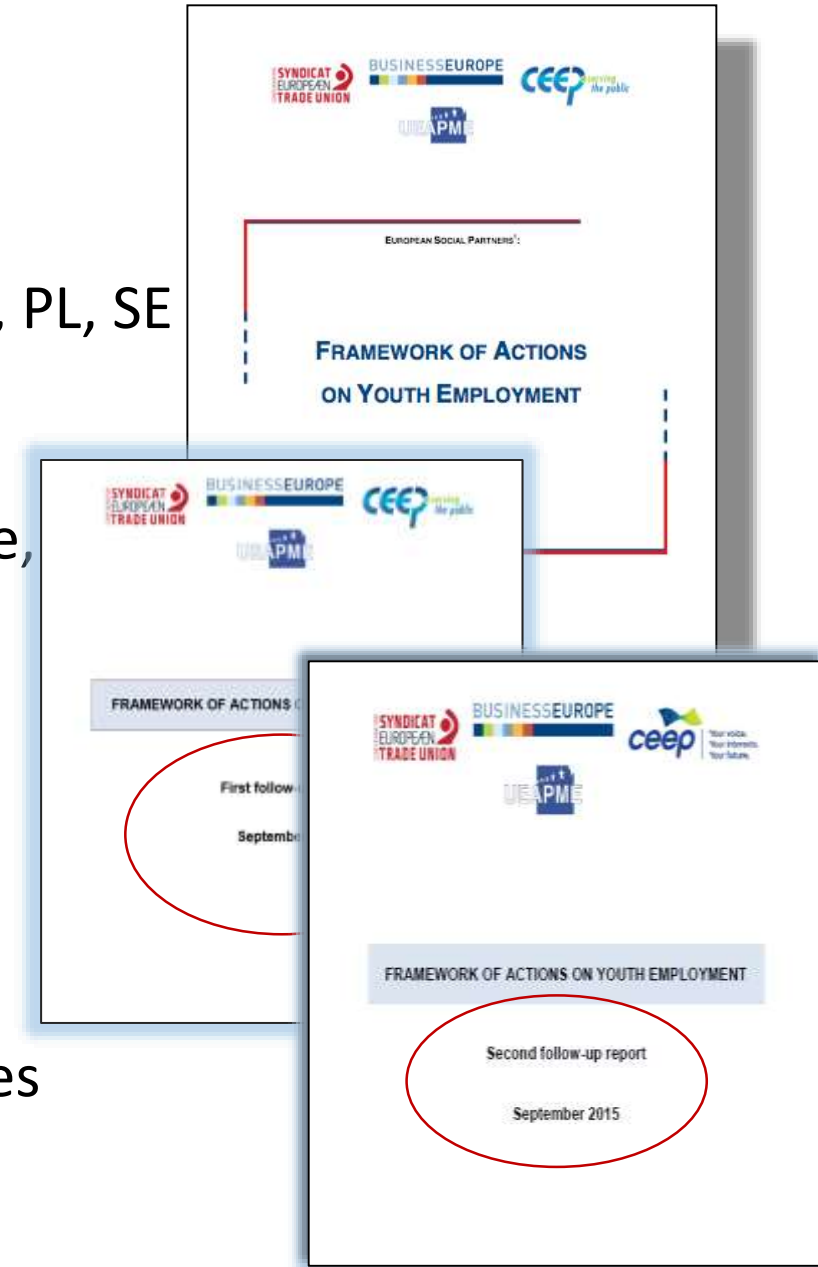
III. Framework of Actions on Youth Employment

- Urgency of the situation
- Priority in our work programme 2012-14
- Long-term / Short-term approach
- Four priorities addressed:
 - Learning
 - Transition
 - Employment
 - Entrepreneurship
- Social partners actions
- Recommendations
- Dissemination



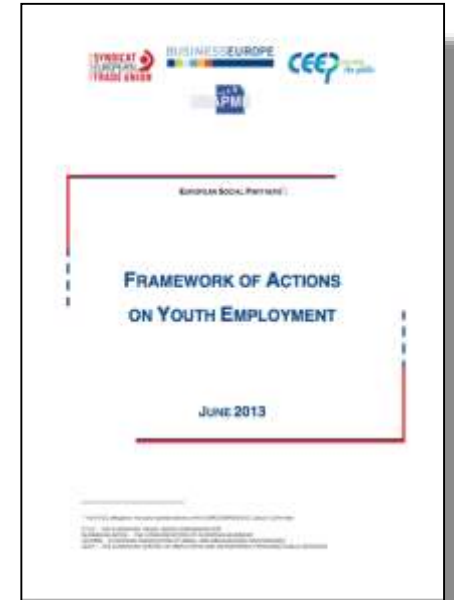
III. Framework of Actions on Youth Employment

- Translated into 10 languages: CZ, DE, DK, FR, HR, HU, IT, LV, PL, SE
- 1st follow-up report adopted Sept. 2014
 - ✓ Follow-up reports submitted by 17 MS out of 28
 - ✓ Several approaches: all priorities at once, one at a time, only some
- **2nd follow-up report adopted Sept. 2015**
 - ✓ Follow-up reports submitted by 21 MS out of 28
 - ✓ Collective agreements used to find solutions
 - ✓ Sectoral approach in apprenticeships and VET
 - ✓ Regional approach characterising intervention
 - ✓ Macro-economic situation continues to pose challenges
 - ✓ Role of European funding opportunities



III. Framework of Actions on Youth Employment

- 3rd follow-up report expected in September 2016
- Based on joint national inputs
 - Recent developments should be included
 - in relation with content of the text
- Call for input - Objective: 28 countries covered
- 2017: conference to prepare for the final evaluation report
