First comment:

Situation seems a bit better than what the JR 16/10/2015 seemed to show.....BUT

... there is still room for real improvement in some countriesthere is scope for all stakeholders to consider further initiatives to ensure that the objectives of the AFAs are reached.

Main conclusions about implementation (1)

- Translations: 2 countries +; 4 -; 2 done some.... > knowledge?
- Green: 6/10 Orange: 6/10 Red: 8/10
- Tripartite SD still main level in several countries

Main conclusions about implementation (2)

- Positive role of Governments in some countries: others negative with interferences in NSD
- Instruments: binding parts = Gvt; minority triggered by NSP

non-binding guidelines but few articulated with lower levels (sector, company)

few if none binding CBA

Main conclusions about implementation (3)

- Need transferable good practices and capacity building
- Danish example of joint commitment for the implementation
- Regular monitoring after project: update tables
