Key Facts and Figures

Commission decision of 20 May 1998 – 98/500/EC

Central bodies for consultation, joint initiatives and negotiation

The social partner organisations must apply jointly to the European Commission

Relate to specific sectors or categories, and be organised at European level

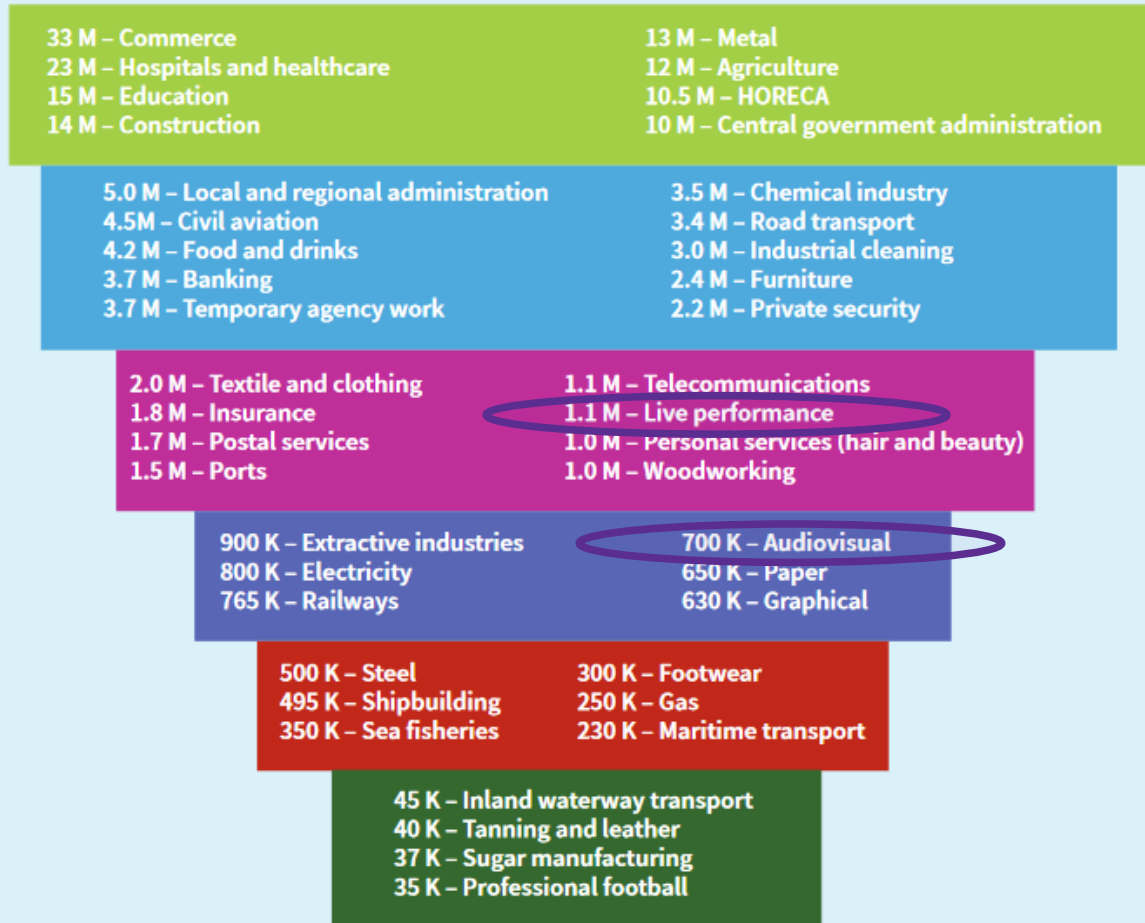
Be part of Member State's social partner structures, and have the capacity to negotiate agreements

Have adequate structures to ensure their effective participation

What added value to a **sectoral dimension** in social dialogue?

A **more granular focus** on specific sectoral challenges is possible. This can allow for outcomes specifically tailored to the sector and its workplaces

Certain **joint framework agreements** have been developed at sectoral level: working time of seafarers; in civil aviation and in inland waterways, working conditions in sea fisheries, maritime transport; multi-sector agreement on handling of silica, etc.

Capacity Building: involvement in European discussions and information exchange, as well as targeted capacity building project work has a positive effect on national level sectoral Social Partners. Engagement with employers in another context/

Produces (Softer) Outcomes with a positive impact in the sector: standard setting, awareness-raising, joint advocacy and input into relevant sectoral policy and legislative initiatives.

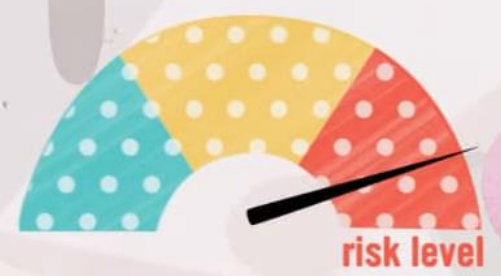

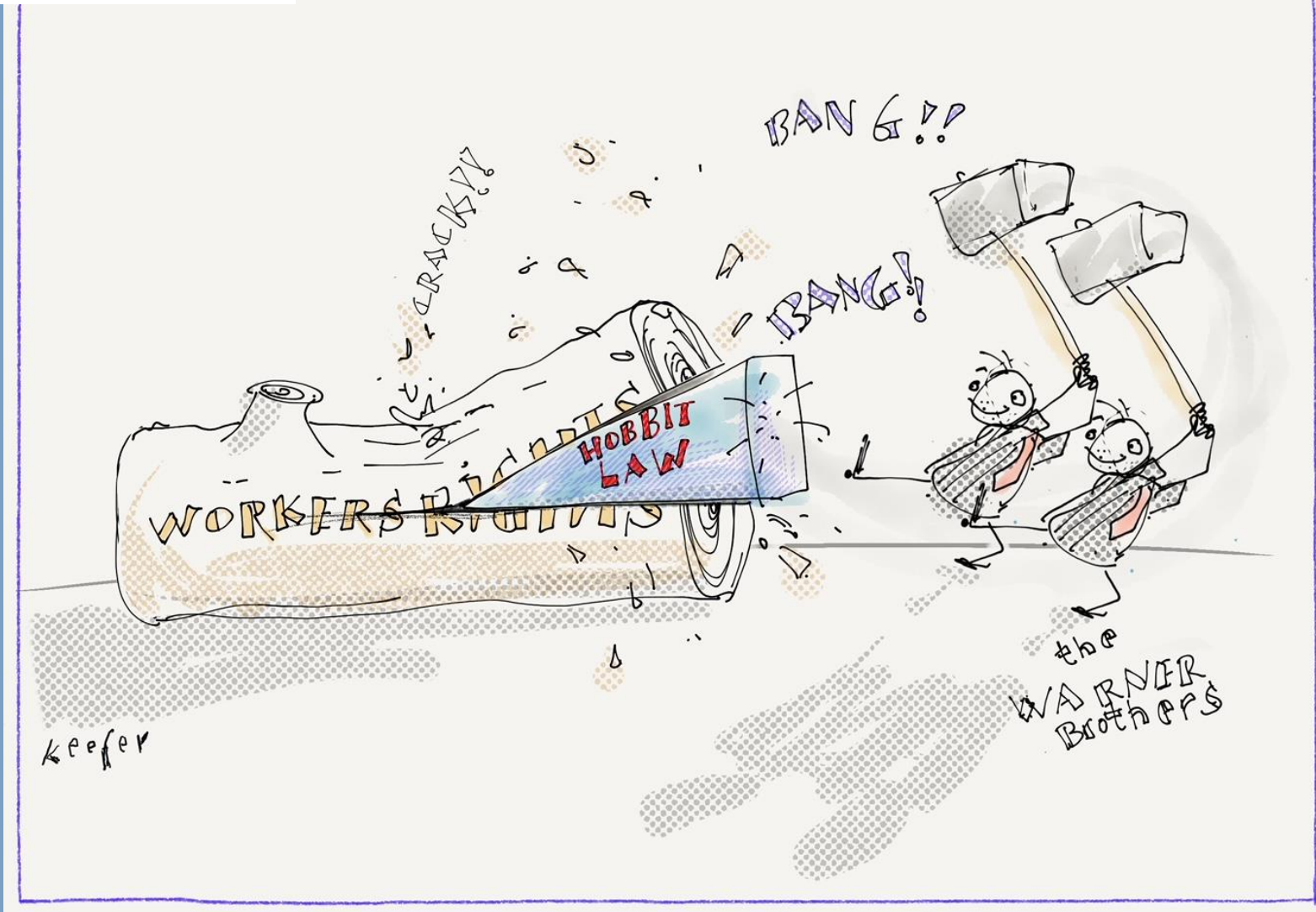
